

Contractor Environmental, Health & Safety Agreement

As the duly authorized and designated representative or agent of _____
(herein referred to as "Contractor"), I hereby certify and agree for myself and for and on behalf of "Contractor"
that:

- I have been advised and instructed by Waupaca Foundry, Inc. concerning working conditions, including known hazards, if any, involved in the job and/or job location at which Contractor, Contractor's agents, subcontractors and employees will be working or be present.
- I have instructed, or will immediately instruct all agents, subcontractors, and employees with respect to the conditions and hazards identified in the Waupaca Foundry, Inc. Contractor meeting, with respect to proper safety precautions to be observed.
- All necessary, adequate and operative protective clothing (to include, but not limited to tight fitting safety glasses, safety toe shoes w/ metatarsal guards, hardhats, gloves, fire resistant clothing, welding equipment, etc.) and/or other equipment such as fall protection, lockout, and air monitoring equipment has been, or will be provided by the Contractor to all such agents, subcontractors and employees, together with full instructions and training for their proper and safe use.
- I am aware that all personnel, while performing work on Waupaca Foundry, Inc. property, are at a minimum required to wear gloves, tight fitting goggles or gasket type seal safety glasses, hard hat, safety toe shoes, hearing protection, and carry company and personal identification. This equipment is required regardless if work is inside or outside of the buildings. Work performed in any designated "Hot Zone" will require additional training and PPE, including fire resistant clothing.
- The Contractor will implement the appropriate environmental, health and safety procedures immediately. **The Contractor is responsible to supervise all of its agents, subcontractors and employees in such a manner so as to ensure compliance with the aforesaid requirements and equipment, and strict observance of all applicable federal, state and local safety rules and regulations.** This includes applicable rules and regulations of the Occupational Safety and Health Administration (OSHA) and the Environmental Protection Agency (EPA) and any corresponding state agencies.

Waupaca Foundry, Inc. is regulated by the OSHA - 29 CFR Part 1910 standard; therefore, all contractors of Waupaca Foundry, Inc. shall also abide by these regulations in addition to their own, while performing services for Waupaca Foundry, Inc.
- I have been familiarized with regard to the Waupaca Foundry, Inc. Environmental Management System, the Health and Safety Management System, the Energy Management System and the Environmental, Health and Safety Policy, as well as the Waupaca Foundry Energy Policy. I am aware of the aspects of my service that may result in negative environmental impacts, and/or health and safety risk if not properly managed. I agree to perform said services in conformance with the Waupaca Foundry, Inc. Environmental, Health and Safety Management Systems; and Environmental, Health and Safety Policy to minimize or eliminate negative environmental impacts and/or health and safety risk.
